Tom Lentz presented to the Board that the site of the future ARC Bus Garage cannot be built in the location planned due to 15' sewage easement. Board suggested that a garage can be leased nearby or build one on future purchased land.

Ray Miller of the ARC Advisory Board spoke about raising the ARC membership fees by \$5 for individual and \$10 for couples. Supervisor Rich Farr would like to wait for another year to possibly raise the membership due to having enough money for another year to provide for ARC. Mel Schultz believes that people outside Normal-Bloomington should pay more. Bloomington is planning on contributing \$40,000 for 2017.
