Received appraisals from attorney on appeal to Property Tax Board. All were considerable higher. After Property Tax Appeal Board ruling, there can be appeals to the court system. He expects to get new appraisals on Menards and Home Depot. Discussed how he manages his staff's time worked and benefit hours.

Mel Schultz made the motion to pay Tarter \$162,096.33 if all waivers and work have been completed correctly, have received all warranties, Mechanical Operational Meeting is completed and Punch List is finished and approved by Farnsworth. Ray Ropp seconded and it was approved

Mel Schultz made the motion for JG Stewart to increase the West parking lot by 10 spaces and adding the sidewalks needed for \$19,721.50. Randy Schaab seconded and was approved

Randy Schaab left meeting at 10:03am

The revised lease agreement with Illinois State University Speech and Hearing was discussed. There is a 3 -year lease with option for 2 or 3 year extension
