# ARC Director of Operations Report May 21, 2020

- Preparations continue on the building prep for the eventual reopening. Farnsworth conducted a walkthrough on May 4 to inspect areas identified on our punch-list for repair. Vissering was in the building on May 12 for the final walkthrough with building inspectors, fire department, electrical, plumbing, etc. A flooring repair person replaced vinyl in some areas of the walking track that were causing trip hazards. Painters were completing touchups on the exterior of the west façade and a few areas on the interior walls. Additional surveillance cameras were installed and functioning.
- 2. ARC managers and Sarah have begun weekly staff meetings on Zoom to discuss preparations for opening. Discussions are focused on identifying a way to operate the facility with reduced attendance to meet safe guidelines; a way to register their attendance and participation in activities in an equitable way; check in members with notouch protocols; and provide activities that have minimum contact and exposure. We have identified up to eight spaces that can be used for activities.
- 3. Member Services Reps have been active helping with the Telephone Reassurance as part of the Sunshine Program. Two MSRs have been phoning members for two hours each day between 10am and 12 noon to conduct a wellbeing checks. More than 100 calls are made a week. MSRs Ruby Jones and Jeanie Whitehill have been assisting managers with hosting Zoom chats and activities. Members who need face masks are provided a mask donated by volunteers who sew.
- 4. The Illinois Department of Human Rights requires Illinois employers in compliance with **Public Act 101-0221** (commonly referred to as the Workplace Transparency Act) complete sexual harassment training annually for all staff by December 2020. I have identified a facilitator and will be scheduling training for staff using Zoom in June.
- 5. Sammi is continuing to complete a July Facebook schedule that we can adhere to in the event that we resume operations.
- 6. Portillo's Drive-Thru Dine & Donate event will be held 4-8 PM on June 16th. Can show digital flyer from Facebook or just mention ARC Living Memorial Fund when ordering/paying. Sammi's goal is to keep us on our regular quarterly Dine & Donate schedule.
- 7. ARC's annual Memorial Day Recognition Ceremony will be Saturday, May 23 on video through ARC's social media. Chaplain Colonel David Terrinoni will video the program at ARC on May 19 and it will include a video of a Military Rites ceremony by the American Legion Honor Guard.
- 8. Retired ISU faculty Mary Campbell will host our first Zoom Senior Scholar on May 27 at 1pm. Past participants have been personally invited by email to join. Her topic is "Solving Community Problems Through Intentional Community Collaboration." Toni Tucker,

director of the Ewing Cultural Center at Ewing Manor will be our June Zoom Senior Scholar presenting on Hazel Buck Ewing.

- 9. Members continue to mail in membership renewals and include notes stating they appreciate what ARC is doing during this difficult time.
- 10. Digital programming has been hit and miss. Successes with members accessing Zoom has been great among groups that have more established communities such as Quilting and Sewing, Great Books, ARCoustic Jam, Line Dance, Tai Chi, and Meditation. Videos for yoga are well received. Cafe Chats and Social Chats are the least attended because these are random gatherings.
