7. Reports

• Community Engagement

Supervisor Sarah Grammer was invited by the Illinois Solar Education Association to be one of two speakers who shared how governments can benefit from investing in Solar. She was able to relate Normal Townships' experience with the ARC solar array to some forty Illinois government bodies that were represented in the meeting.

Trustee Aper met with investors at the Assessor's office. He noted that the website is less user-friendly than the former site. Assessor Cranston and Supervisor Grammer agreed but mentioned that work is currently underway to address that challenge.

Trustees, Sally Pyne, Arlene Hosea and Clerk Pat Turner attended the annual Town of Normal Citizen of the year event where Mike Matejka was named as this years' chosen honoree. All were pleased to represent Normal Township at the event.

Assessor-

Assessor Cranston shared a summary of his report for 2021 Assessments. Cranston explained that the county assessor determined that a multiplier of 1.0105. was warranted. The report summary reflects a net increase from 2020 EAV, which is about double the amount of the last couple of years. Cranston noted that the cycle is not yet complete as the report has yet to be shared in the local Normalite newspaper and go before a review board.

Clerk- No Report

Highway Commissioner-via Zoom

Commissioner Rader reported that a road project aimed at seal coating 5 ½ miles county road was started yesterday afternoon and should wrap up today. Culvert replacement work for field entrances is also underway as the rains have caused some problems. Moving is being done around ditches and

guard rails as well. There is an additional micro surfacing project on 2 miles of Towanda that will hopefully start before winter. Commissioner Raider said the Township attorney has reviewed the building contract and he is working to finalize everything so that it will be ready to sign soon.

· ARC Staff and Senior Advisory Committee-

Elischa Sanders, Membership Director shared that ARC membership is still increasing in spite of the mask mandate being reinstated. She sees as many as 5-10 new members a day and some are using the portal to sign up online as well resulting in new members joining even over the weekend. There currently are a little over 2,100 active members.

Sammi Scott, Communications Coordinator shared that Bingo and Coffee sponsorships are going well with some dates left to fill for 2022. They are looking forward to Senior Citizen month and the upcoming open house. Sarah Grammer shared that there have been several cool prizes that have been donated to be raffled off and encouraged everyone to attend and invite others to come to the ARC open house on Saturday, September 18th, 10am-Noon.

Arlene Hosea praised the July 29th outdoor concert that the ARC put on. It was well attended and good feedback was received. Molly, Director of Programming, is looking to do more like that event next summer.

Supervisor

Supervisor Grammer shared that we are seeing our lowest numbers ever for those on monthly General Assistance. She attributes that to the fact that more people are finding employment including those who traditionally have been hard to place. There have however, been several calls a day for those seeking utility assistance and help with water payments as disconnect notices have resumed.

Sarah shared that Preston continues to seek a solution for, and the source of water coming into the building at the ARC. He is seeking an expert that will help investigate and address this issue. He should have an update by next board meeting.

Regarding the Greenspace project, the most recent cost estimates are still higher than desired. After meeting with Kathy Bilow and Preston, it was determined that there are still several changes that can be made to the proposal to decrease cost such as eliminating drainage tiles where drainage is adequate and reduction in landscaping. The current plan includes decorative stonework that could also be removed to decrease costs. The board agreed that it is best to get the plan within budget than to rush the effort.

A. Presentation of FY2021 Audit-Robert McGlade -Auditor

Auditor Robert McGlade presented a page-by-page review of the Audit for Normal Township for FY2021. He shared that in the unmodified opinion of the auditors, the financials present fairly in all material respects and that the Township is operating under budget. It was noted that some numbers present lower than in previous years as a result of the closure during the Pandemic. The final audit report will be turned over to the Comptroller.
