1. **Budget Hearing:** Public Hearing on Township and Road & Bridges Budgets for FY 2023 was called to order at 8:15 by Township Supervisor Sarah Grammer.

Supervisor Grammer opened the floor for those present and attending via zoom to give feedback on, or ask questions regarding the Township Budget and Road and Bridges Budget for FY2023. She confirmed that both budgets had been advertised for the last 30 days. She shared that the Normal Township Budget with total appropriation of \$2,798,025 included the following:

8. Reports

A. Community Engagement

Trustee Pyne attended the Trustee training held at the Doubletree. She and Trustee Hosea attended a training on how communities can address the opioid crisis while collaborating with other government entities. She expressed that the issue affects our senior population and felt the information was worthwhile. In response, Trustee Rodriguez suggested a future prescription disposal event for the ARC. Arlene also reiterated the seriousness of the issue and shared about additional upcoming events on the subject. Sally also attended a community partner event at ISU. There she learned of a cash crop (Cover Cross) that can be planted between October and May. Additionally, Trustee Pyne attended a League of Women Voter event that focused on teaching civics in the high schools. Trustee Art Rodriguez visited Heartland Community College for a meeting on a proposed Safety Department that would be based on campus. Trustee Floyd Aper took part in a webinar on changes regarding financial disclosures. He

emphasized that elected officials are required to comply with their local county clerk. Trustee Arlene Hosea attended the meeting of the Senior Advisory Board and commended the group on being dynamic and conscientious.

B. Assessor- No report at this time.

- C. Clerk- Township Clerk Pat Turner expressed appreciation for Sarah Grammer, Arlene Hosea, Mary Wurhman and all those who came together to help the Annual Town Meeting run smoothly while she was out with pneumonia.
- D. **Highway Commissioner-** Arin Rader reported that he has done some recent shoulder work on the roads to prevent cracking. He is also re-doing some field entries for widening and drainage. He also held a bid opening for the new maintenance building.
- E. **ARC Staff and Senior Advisory Committee-** Supervisor Grammer acknowledge Deb Shaw who was present in person and thanked her for stepping up to serve as the Advisory Board Chair. Director of Operations Jess Ray shared that the ARC was honored with a Patriotism Award by the AMVETS for flying the Flag. He gave additional updates including the ARC Volunteer Appreciation Event on April 12th, the kick-off of the "Greenspace Project" which is on target for an early June completion. He encouraged all to attend the ARC Anniversary Celebration on April 25th and announced an upcoming booster clinic in partnership with the McLean Co. Health Dept.
- **F. Supervisor-** Supervisor Grammer re-iterated the upcoming 6-year Anniversary of the ARC and shared that "Meltdown Creative" Works will be on-site to make T-shirts. Sarah reported on her research on a possible van trade-in for the ARC. She noted that significant complications are involved if the consideration is trading the non-accessible tour bus for an ADA accessible minivan. She shared that a trade in for a new vehicle at \$29,000 or a Hybrid Rear-Loading vehicle at \$26,000 would require us to go out to bid as they are above our current bid threshold.

10. New Business

Commissioner Rader sought approval to increase the maintenance and contractual services line #2 of the budget from \$10,000 to & \$20,000 to reflect the cost of repairs for a truck which have already eaten up the allotted budgeted amount early in the year. The increase would change the total appropriations to \$2,111,050.

B. Discussion and vote to adopt FY 2023 Normal Township budget Motion to Approve: Motion: Sally Pyne Second: Arlene Hosea

Supervisor Grammer sought approval to increase the General Town (maintenance service equipment line) from \$20,000 to \$30,000 to cover equipment repairs done in the ARC Fitness Center. The work was allotted for and started in the previous fiscal year but could not be completed until this current year due to delays in the ability to get needed parts. This would change the General Town line from \$1,529,475 to \$1,539,475.

C. Discussion and vote on the transfer of funds between budget lines

Supervisor Grammer explained that state statute allows for the transfer of funds between budget lines to assure that no line is exceeded. While the budget was written with the best intentions on spending, this year was particularly complicated for ARC as it came off of an entire year of closures during which no programs were underway. Utility rate increases and other costs as programming resumed created the need for some budget repair.

D. Discussion and vote on contractor for new Road & Bridge building

Commissioner Rader reported that a bid opening was held last Thursday for the maintenance building. Arin shared that there was only the one Bid "CAD Construction from Tremont. While the architect had worked with the company before, the bid was over-budget by \$171,000. Rader talked with the architects about the possibility of re-bidding, however he is concerned that that pushes the start date out significantly and may take the project into the next fiscal year with additional costs quite probable. The board discussed options at length and ended with a suggestion that Arin have the Township Attorney review the contract before making any final decision.

F. Discussion of Road & Bridge funds

Trustee Floyd Aper raised questions about communication received from Town of Normal Councilman Stan Nord in reference to the 50% of the road and bridges appropriation to the Town of Normal. 605 of the IL Statute 6-507 mandates that half be collected and sent to the municipality. Mr. Nord had questions regarding how the sent funds are used. Aper also sought clarification regarding a follow-up email from Supervisor Grammer to the Township Trustees following Mr. Nord's communication. Supervisor Grammer clarified that her email was simply to remind Trustees to be mindful of actions done on behalf of our "governing body" so that we remain in compliance with the open meetings act. After additional discussion among the board members and input from Councilman Nord, Trustee Aper asked that Pam Reece from Town of Normal, and that a representative from TOI (Jerry Crabtree) be invited to share on the issue at a subsequent meeting.
