

TOWNSHIP INFORMATION AND SUMMARY DIRECTORY

Normal Township

The township government is established and empowered to perform certain governmental functions as directed by the state Constitution and Legislature.

Normal Township is a municipal corporation organized under the laws of the State of Illinois and established in 1857 for the purpose of providing its residents with the following services:

- Road & Bridge Maintenance and Construction
- Property Assessment
- General Assistance
- Emergency Assistance
- Services for Youth, Disabled and Senior Citizens

The Township is organized with two (2) separate chief executive officers, namely the Supervisor and Highway Commissioner. The organization charts shown on Tables I & II demonstrate the relationship of the various offices of Township government. The Supervisor is ex-officio Treasurer of the Road District. The Highway Commissioner can act solely or in concert with the Board of Trustees. The Clerk serves as record keeper for both the Township and Road District.
